### September 2020 Board Meeting

The September Board meeting was held at QEII Medical Campus on Thursday, 3 September 2020.

At this meeting the Board received a presentation from Dr Jodi White, Head of Department, Forensic Pathology and State Mortuary Service. Dr White provided an overview of the Department, current issues for the service and an update on the State Mortuary Refurbishment Project, with the upgrade due to be implemented in 2021. Following the meeting, Dr White provided a tour of the State Mortuary, which enabled our Board members to familiarise themselves with the service. Dr Sue van Leeuwen, Board member provided the below reflection on the tour:

*The passion that Dr Jodi White spoke of the service was impressive.*

*Our site visit was comprehensive, seeing all aspects of the State Mortuary. Jodi's knowledge of the service was noteworthy, answering every question we had professionally and in depth.*

*Each Board member felt the bereavement service offered to families visiting their loved ones in the mortuary was important, providing critical support and value to families during a difficult time in their lives.*

*The Board are excited and committed to the much-needed redevelopment of the State Mortuary.*

The Chief Executive also provided the Board with a comprehensive update on the Laboratory Information System noting the current status, summary schedule, governance structure and projected order of tests transitioning to the full implementation of Soft. The

Board were impressed with the progress of this project to date and eagerly await further updates around the three (3) main tertiary sites going 'live'.

### **Key matters for discussion**

- PathWest Forensic Biology Advisory Council draft Terms of Reference. The Council is due to be established as a part of the *Ross Inquiry into PathWest Laboratory Medicine* WA Report Recommendations. The Honourable John Chaney will Chair the Advisory Council, which will provide advice and support to the Board on Forensic Biology matters.
